- Rabies Clinic The rabies clinic has been scheduled for May 6, 2023. Jolene will make placards to post.
- Clean Up Days The dump will be open for clean up days on May 6th, June 10th and June 24th. The Container Site will not accept batteries, construction demo, tires and appliances must have coolant removed and be tagged by a certified heating/cooling person. The Container Site will remain open as long as people are dumping on those days.
- Dump Site Locks The combination lock on the dump site gate was cut and removed. The gate was tied shut with a rope. Mark replaced the lock with a key lock.
- Park Lights Mayor Thielen has been receiving complaints about the light on the back end of
 the park not being turned on. No one could remember the last time it was actually on. There
 was discussion about if the light has not been on for several years is it actually necessary and
 worth the cost of turning on.
