- DEQ sent a reminder about the public hearing for NEW RULE 1
- Corrine Sander submitted a records request for a copy of the Lagoon PER. She was provided with a draft copy.
- Jolene had a phone call inquiring about the sink hole in front of Marge Griebel's house. The sink hole has been filled in with gravel but is a short term fix. Councilman Higgins will donate his trailer to get hot mix from Wyrick Construction but will need help shoveling the hot mix.

A motion was made by Councilman Franson, seconded by Councilman Hillard to have Councilman Higgins purchase the required supplies to fix the sink hole.

Old Business:

- Mowing the Lagoon Rick has mowed the lagoon, as well as the bulk water site and dump site. The Fire Dept will burn the rest as it was not safe for Rick to mow it. Robin with Montana Rural Waters has contacted Jolene and should be down this week to take a look at the lagoon and see if he can offer any advice or assistance.
- Raise sewer rates/Budget Prep Jolene presented the council with a spreadsheet showing what was budgeted and what was actually spent. The water fund spent more money than it made last year. The council reviewed the suggested rates that the representative from MT Rural Waters made after looking at our system and suggested raising the water rate \$15, the sewer rate \$20 flat rate and the garbage rate \$5. Jolene will get the notice for the public hearing put together, posted and scheduled for August 29th.

New Business:

• Year End R&D Transfers – Jolene presented the council with the Year End R&D transfer numbers.

Department Reports:

- Water/Wastewater Operator Rick reported he had an annual water test and asbestos water test coming up.
- Container Site Operator Mark was absent.
