Correspondence:

- Fallon County Planning Board sent a letter requesting the Plevna Council attend their next meeting to discuss the planning fee schedule for the entire county.
- Corrine Sander submitted a Records Request for a Council Meeting Packet.
- City of Baker sent a letter outlining the mosquito control program and the projected fee for this year. They will come spray as needed.
- The state sent the Fuel Tax Allocations for FY22. It is on file at the Town Office.
- Bank of Baker sent notice of a substitution of collateral notice. Mayor Benner will meet with Carol at the bank to get more information.

Old Business:

Grant Research – The Town is still waiting on the PER to be finished for the wastewater site. In order to be eligible for additional ARPA competitive grant funding, this would have needed to be finished and in hand. The Town is still able to request distribution of some ARPA funds.

Wastewater Operator Job Posting – The Clerk will arrange an interview time for the operator applicant and the Council.

Ordinance #55 – A motion was made by Councilman Hoffman, seconded by Councilman Vennes, to do the final reading of Ordinance #55.

- Container Site Operator Mark will fill the rest of the container from clean up day, then notify the Clerk so that half the fee can be requested from the County.
- Bulk Water Pumping Site Mark will take a look at the light down at the pumping site to get it turned off during the day. He will also spray the weeds.
- Wastewater Operator —Rick turned in the Wastewater Operator Log and noted that the vegetation would need to be cut this summer. He would like to get a schedule set up to clean ¾ of the sewers this summer/fall. The Council will help as they can. DEQ will be coming within the month to measure the sludge in the lagoon cells. Rick will be there along with Rich Menger.
- **Human Resources** Julie will meet with the Clerk in a couple days to work on the Clerk/Treasurer job description.

Clerks Report:

Past due accounts will be notified. The Water Operator will be on vacation so there will be no shut offs this month.

The Town has been added to the schedule for Prairie Fuels to periodically check the propane levels in the generator tank.

Michelle Gray has made an amendment to her Zoning Conformance Permit, moving her storage shed 12' from the west boundary of her property. This is still within the allowed setbacks.

Nuisance letters for leash law, mowing, and debris/decay were discussed with the Council and the Clerk took note of which properties should receive a letter.

Financial Report — May 2021:

The May financial report was reviewed and accepted by the Council.

<u>Mayor/Council Comments:</u> Councilman Higgins noted that the Town could use eight loads of hot mix to patch the streets.

Approve Claims:
