Old Business:

- ARPA Minimum Allocation Grant There will be a public hearing on Monday, May 15, 2023, to go over the environmental review checklist. Once that is complete, we should get the funding on the grant.
- Montana Rural Waters water loss. Rick was absent so he will report on this next month.
- Container Site locks Cliff Tudor stated that the locks were changed and Happy Camper was not given any notice. He would like to have a copy of the key to the new lock as they have to keep up with the garbage at the RV Park to be in compliance with sanitation issues and the amount of garbage generated at the RV Park is higher volume. Jolene stated that Scot Buerkle came by the office and would also like access to the container site. Scot mentioned the Town should get cameras and a key pad like they have at the gun range. Mayor Thielen did not want any copies of the key going out, especially with there being problems with cutting the lock. Mayor Thielen also stated that there will be equipment stored there in the near future so it is best to keep the container site secure. Cliff was still concerned about the garbage piling up at the RV Park. Jolene told Cliff to stop by the office and she would go to the container site with him to give him access to accommodate him. Cliff requested that Jolene provide Happy Camper with something in writing to post at the RV site stating that this would be the procedure. Jolene will email him something he can post.

New Business:

- Update addresses Jolene is working with DES and Fallon County to update and make sure the addresses are correct and current.
- Zoning Commission with Vivian Panasuk passing, there is an opening on the zoning commission. Jolene will check with Darcy Wassman and see if there is a conflict with having someone on both the council and zoning commission.
- Container site/Bulk water weed control Mayor Thielen would like to have both sites sprayed with ground clear to keep the weeds down. Jolene will check with Fallon County (Sara Berger) to see if they can spray both locations.

- <u>Container Site Operator</u> Mark stated the other container got dumped.
