

**REGULAR MEETING OF THE TOWN OF PLEVNA—Monday, November 9, 2020, 7:00 p.m.**

Councilman Gary Thielen called the meeting to order in place of Mayor Benner at 7:00 p.m. As Acting Mayor, Councilman Thielen excused himself from any voting to take place.

Councilmen present were Jordan Hoffman, Alba Higgins, Kyle Vennes, and Gary Thielen.

**Public Comment: None**

**Correspondence:**

- MT Dept. of Administration, State Financial Services: An approval letter was received for the Town's application for Small Government Financial Reporting Framework (SGFRF). Rachel's Accounting has been notified to proceed with the Town's AFR.
- Fallon County Environmental Health: Rich Menger sent correspondence that the clean up of the former Plevna Garage will proceed. Rich also forwarded a letter outlining the extension of the Town's Grant RPG-20-0664 that was received for work on the lagoon system.
- Midco Diving and Marine: Plevna is still on the schedule to have the water tank cleaned. They expect to arrive sometime at the end of November.

**Old Business:**

**Sidewalk Bid** – The sidewalk project will be tabled until next spring.

**New Business:** No new business.

**Department Reports:**

- **Water Operator** – Rick visited J&B in regard to their meter. He will check it again next month. Gene Vennes is concerned that his meter is still not reading correctly. Rick put in a new meter for him a couple months ago. The meter for the pump house has been sent off. Rick will also check Marge Griebel's pit for water.
- **Container Site Operator** – The Town's lidded container has still not been returned. The container site policy is that there is no after hours dumping of garbage allowed, only tree branches. A dump time must be arranged with Mark.
- **Bulk Water Pumping Site** – Cliff Tudor removed the building from the Nemitz property and set it at the Railroad Well site. Councilman Thielen will talk with Mark about checking the bulk water pumping site more regularly.
- **Wastewater Operator** – The operator turned in the lagoon log sheet. The sewer cleaning was not completed this year. It will now be two years since the sewers have been cleaned out.

**Clerk Report:** The past due accounts were reviewed with the Council and shut offs were scheduled.

**Financial Report — October 2020:**

- The October financial report was reviewed and accepted by the council.

**Mayor/Council Comments:** No additional comments.
