#### ORDINANCE NO. 54

# AN ORDINANCE ADOPTING THE 2017 TOWN OF PLEVNA ZONING CODE AND OFFICIAL ZONING MAP #1 FOR THE TOWN OF PLEVNA, MONTANA.

WHEREAS: § 76-2-301 et. seq. of the Montana Code Annotated authorizes the Town of Plevna to adopt and enforce local zoning regulation to promote the public health, safety, morals, or the general welfare of the community; and

WHEREAS: The provisions of Montana Law allow municipal governments to regulate and restrict the height, number of stories, and size of buildings and other structures; the percentage of the lot that may be occupied; the size of yards, courts and other open spaces; and

WHEREAS: It is in the public and private interest for the Town of Plevna to establish use controls that limit the density of population; and the location and use of buildings, structures, and land for trade, industry, residence or other purposes; and

WHEREAS: The Town of Plevna is a General Powers government; and

**WHEREAS:** The Town of Plevna Planning Board and Zoning Commission prepared Zoning Regulations and a Zoning Map for the Town of Plevna; and

**WHEREAS:** The Planning Board and Zoning Commission did on July 11, 2017 conduct a public hearing on the proposed regulations and map; and

**WHEREAS:** The Planning Board and Zoning Commission on a 2-0 roll call vote recommend that the Town Council adopt by ordinance the Zoning Regulations and Zoning Map for the of Town of Plevna, Montana; and

**WHEREAS:** The Town of Plevna Council did conduct a duly noticed Public Hearing on August 14, 2017 on the proposed Zoning Regulations and Zoning Map.

Now therefore:

#### BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF PLEVNA, MONTANA:

The Town of Plevna Municipal Code is hereby amended in those parts set forth below to read as follows:

Title 10 Chapter 1 of the Town of Plevna Municipal Code shall be the 2017 Town of Plevna Zoning Regulations including Official Zoning Map #1.

Be it ordained by the Council members of the Town of Plevna.

- 1. The Town Council of the Town of Plevna hereby adopts the 2017 Town of Plevna Zoning Regulations and Official Zoning Map #1.
- 2. All ordinances or parts of ordinances inconsistent with the ordinance are repealed on the effective date of this ordinance.
- 3. It shall be the duty of the Town Clerk to maintain the official zoning map.

- 4. It shall be the duty of the Town Clerk to file a certified copy of the Ordinance, the Zoning Regulations and Official Zoning Map with the Fallon County, Montana, Clerk and Recorder.
- 5. This ordinance shall be in full force and effect thirty (30) days after its final adoption by a majority of the elected members of the Town Council

First reading by the Council on the 14<sup>th</sup> day of August 2017.

Second reading by the Council on the 11<sup>th</sup> day of September 2017.
