#### **Old Business:**

- Fireworks in Town limits Councilwoman Miller put together some ideas on guidelines for fireworks in Town. The council reviewed the ideas and would like Jolene to proceed with putting the fireworks guidelines into ordinance format.
- Budget The State reviewed the budget and informed Jolene that the general and gas tax funds exceed 50% of the total appropriations. Also, the water fund is more than 2.5 times total appropriations. With the extra gas tax funds this year, the council would like to continue to get more scoria and get the alleys built up before winter sets in. Jolene is to look into getting more information on the meters and see what the installation time would be. That could also be a potential project to get taken care of before winter. Also, Jolene is to get in touch with Clint Olsen and see if he would be willing to cut the tree down that is in the boulevard across from the Catholic Church.
